Allegheny Energy Awards \$30,000 TechConnect Grant to Williamsport High School *Contribution to Purchase Computer Equipment for Classroom Instruction*

Hagerstown, Md., October 25, 2001 – As part of its proud and enthusiastic commitment to communities, schools, and students, Allegheny Energy, Inc. (NYSE: AYE) announced today the award of a \$30,000 TechConnect Classroom Technology Grant to Williamsport High School. The TechConnect grant, which will be used to purchase computers, printers, servers, and other computer hardware, will assist the school in improving its technology programs in math and science.

More than 200 schools submitted grant proposals, which were evaluated by teams of educators and business leaders.

Giles, Principal, Williamsport High School. “The TechConnect grant will provide a computer lab to be used by students and teachers in science and math content areas.”
