#### **Allegheny Energy Awards \$30,000 TechConnect Grant to Buckhannon-Upshur Middle School**

*Contribution to Purchase Computer Equipment for Classroom Instruction*

**Hagerstown, Md., October 26, 2001** – As part of its proud and enthusiastic commitment to communities, schools, and students, Allegheny Energy, Inc. More than 200 schools submitted grant proposals, which were evaluated by teams of educators and business leaders.

“We can now take advantage of the Dell mobile computer lab to assist all students, especially those having difficulty with science or reading,” says Sam McComas, Principal, Buckhannon-Upshur Middle School. “The TechConnect Grant will enable us to enrich and enhance our curriculum.”
