Allegheny Energy Announces Plan to Refinance Term Loan and Redeem Senior Notes Due 2007

GREENSBURG, Pa., June 27, 2005 – Allegheny Energy, Inc. (NYSE: AYE), today announced that its subsidiary, Allegheny Energy Supply Company, LLC, is launching an effort to obtain a new term loan of up to \$1.075 billion. Allegheny Energy Supply plans to use the proceeds to refinance its existing term loan (currently \$744 million outstanding) and approximately \$331 million principal amount of the 10.25% Senior Notes, due November 2007. Additionally, Allegheny Energy Supply will redeem \$35 million of its 13% Senior Notes, also due November 2007.

The company anticipates closing on the new facility by the end of July, with the funding for the refinancing of the 10.25% Senior Notes expected in August, but can make no assurance as to the success of the above transaction.
